**Term Paper**

The research paper should be on a problem or issue in the historical or contemporary experience of a particular Middle Eastern country or alternatively, it could be comparative. It should be focused, analytic, reflect critical thinking of materials read and must be well-documented with complete references given (at least 10 sources). Internet material should be used with care and very sparingly (Wikipedia is not acceptable). The topic for the term paper must be approved by the instructor in advance. A 1-2 page proposal of your paper is due on **September 21** and the final paper is due on **December 21**. Both the proposal and the final copy of your paper need to be submitted online through Canvas. More details are provided at Canvas.
